SPECIAL NOTE Any exhibitor whose dog passes a Tracking Test AFTER the closing date for the TBHC Test but BEFORE the running of the test may withdraw their entry and receive a full refund of the entry fee PROVIDED that such withdrawal is made by phone, in writing or in person to the Test Secretary prior to the test and in writing or in person to the Test Secretary prior to the test and further provided that an alternate exhibitor is available and willing to take the spot of the exhibitor withdrawing from the entry.

IMPORTANT NOTICES REGARDING OUR TEST SITE:

Exhibitors are requested to not practice at the test site within three days of the test without first contacting the test chair to find out which areas may be used. Exhibitors and spectators are not permitted to park along the park roads. This is a park rule! Designated drivers will take exhibitors and spectators to drop-off or viewing areas.

DIRECTIONS TO THE TEST SITE HEADQUARTERS:

Directions from Titan Road:

Go from Santa Fe to Titan Rd; proceed on Titan Road for 1.8 miles to Roxborough Park Rd. Turn right or south on Roxborough Park Rd. and proceed 1.5 miles to the Entrance Gate. After paying the fee, proceed to Heronry Parking Lot (on the right side) for 1.1 miles. Park in parking lot.

Directions from Wadsworth Blvd:

Proceed south on Wadsworth to Waterton Rd. Turn left and proceed for 4.3 miles to the light at Rampart Range Rd. Turn left (north) on Rampart Range Rd which will turn into Titan Rd. Turn left (south) on Roxborough Park Rd. and proceed 1.5 miles to the Entrance Gate. After paying the fee, proceed to Heronry Parking Lot (on the right side) for 1.1 miles. Park in parking lot.

IMPORTANT NOTES TO EXHIBITORS

CERTIFICATION: With the entry form for a dog that has not passed an AKC Tracking Dog Test, there must be filed an original statement dated within one year and signed by a person who has been approved by the American Kennel Club to judge Tracking Test (or Provisional Tracking Judge), certifying that the dog is considered ready for such a test.

TEST LIMIT AND RANDOM DRAW: This test is limited to 3 TD's and 4 TDX dogs. Entries will remain open until 5:00 p.m. Thursday, February 15, 2018. If entries received exceed the test limit, a public drawing will be held at 7:00 p.m. Thursday, February 15, 2018 at Betty Gene Pearce's home 1500 W. Thornton Pkwy #320, Thornton, CO 80260. Any interested parties may attend. Acknowledgement will be emailed to all entrants as soon as practical. If alternate entries remain after the draw, an additional draw will be conducted to determine the order in which alternates will run. In all cases, preference will be given to BASSET HOUNDS first, followed by all other breeds.

ENTRY FEE: \$60.00 (TD) and \$100.00 (TDX). The entry fee includes the \$3.00 AKC event service fee and the 50 cent AKC recording fee. *Make checks payable to* Timberline Basset Hound Club and send with entry form to: Betty Gene Pearce's home 1500 W. Thornton Pkwy #320, Thornton, CO 80260

ENTRY FEE WILL NOT BE REFUNDED in the event of errors or cancellation of entries after the published closing date (except as noted in the "Special Note" on page 4 of this premium list), nor in the event that a dog is absent, disqualified, excused by the judge or barred from competition by the test committee. If, because of storms or other acts beyond the control of the management, it is impossible to open or complete this event, no refund of entry will be made.

BITCHES IN SEASON MAY PARTICIPATE. The owner of a bitch in season **MUST** notify the Test Secretary prior to drawing for tracks that their bitch is in season. Such bitch(es) will run only after all the other dogs have run and must be kept away from the immediate vicinity of the test prior to running.

USE THE OFFICIAL AMERICAN KENNEL CLUB ENTRY FORM and write "TD" or "TDX" in the "Obedience Class" space. Telephoned, unsigned, conditional, or incomplete entries cannot be accepted. Entries not on an official AKC entry form and photocopies of forms without the Agreement and Instructions on the reverse side of the official AKC entry form are **NOT ACCEPTABLE**.
